**Event Permission Slip and General Release, Assumption of Risks and Indemnification** (rev 11/18)

CRISTA cares about your student's safety; we encourage you to read this document carefully as it affects your legal rights. In order for your student to participate, s/he will be required to have a full functioning ski or snowboard equipment, appropriate safety gear and clothing for snow sports, money and food for the Event.

**NOTICE: This document affects your legal rights, please read carefully. Handwritten changes to this document are not permitted. This Agreement constitutes the entire Agreement between the parties. If any portion of this Agreement is found to be unenforceable, the remaining portions shall remain in full force and effect.**

In consideration of Participant's ability to join this Event, the above Participant (or the Parent/Legal Guardian of Participant), being above the age of 18, hereby agree as follows:

**Permission:** I hereby grant permission for Participant to use school designated transportation to travel to Stevens Pass, Ski Resort and join the King's Alpine Ski Club for the dates listed above.

**Assumption of Risks:** I acknowledge that certain activities associated with this Event, including traveling on wintery roads, exposure to cold conditions, snow sports, running, jumping, activities on ice and snow and physical contact with other riders are inherently dangerous activities, which may result in serious injury to the person and damage to property. Knowing this, I voluntarily assume any and all risks of loss, damage and injury to Participant relating to this Event. I understand that I am responsible for Participant's conduct and safety. I understand that I am responsible for Participant's conduct and will ensure that Participant will follow directions and requirements set forth by King's staff.

**Waiver & Release:** In consideration for Participant's involvement with this Event, I hereby release and forever discharge King's Schools and CRISTA Ministries, and its employees and agents, (collectively referred to as "King's Schools"), from any and all claims, actions, damages, liabilities, costs or expenses and attorney fees that are related to, arise out of, or are in any way connected to, Participant's involvement or participation in any of the activities associated with this Event, or the sole or partial negligence of King's Schools. By signing this Agreement, I intentionally and voluntarily covenant not to sue and waive any rights to seek damages from King's Schools on behalf of myself or Participant; except where injury, death or disability results from King's Schools' gross negligence, intentional or reckless misconduct, or any other liabilities Washington law does not permit to be excluded by agreement.

**Medical Treatment Consent:** I hereby give consent to any healthcare provider to perform any medical procedures that the healthcare provider deems necessary for the relief of pain or to preserve the Participant's life or health if incapacitated (if Participant), or if parent/guardian cannot be reached in an emergency (if Minor).

**Photo Release:** CRISTA may publish photos taken of Participant at the event and I release all rights to remuneration for such photos.

Signing below, I hereby certify that I am over 18 years of age; I have carefully read the foregoing and acknowledge that I understand and agree to all the terms and conditions. I have had the opportunity to ask any and all questions regarding this Agreement and the effect of the same. I am aware that by signing this Agreement, I assume all risks and waive and release certain substantial legal rights.
